## Important dates to remember!

**April 10, 2011 -- NAR Midyear/Legislative Meetings Major Donor Recognition Deadline:** If you have major donors that want to be recognized at the NAR Midyear Meetings, their contributions need to be into the OAR office by April 10 so we can be sure NAR receives the funds by their deadline. Keep in mind that these contributions should be personal contributions not made with a company check.

**August 15, 2011-** This is the deadline for RPAC Contributions to be received at the OAR office in order for Boards to be recognized for reaching goal at the OAR Convention in September. The campaign still continues until October 10, 2011.

**September 11-14, 2011 --** the OAR Convention. The RPAC Recognition Breakfast for OAR Ohio Club, Diamond Club, NAR Sterling R, Crystal R and Golden R members who have contributed this year and/or last year will be held at the convention. Also, any Local Boards who have reached their goal by August 15<sup>th</sup> will receive an award at the OAR Directors meeting.

**October 10, 2011 --** the RPAC Campaign cut-off. Contributions must be postmarked or received in the OAR office by this date to be counted towards 2011.
